### ORDER

As per the Government order read as 1st paper above Administrative sanction was accorded for starting a Self-financing/Un-aided college by the name "Sahya Arts & Science College", Kalikavu road, Wandoor, Malappuram, under the Sahya Tourism & Pravasi Co-operative Society Limited, Wandoor, Malappuram with the new unaided courses of B.Com Finance(30 seats), BA Travel & Toursim(30 seats), BBA(30 seats), B.Sc.IT(24 seats), and BA English(24 seats) , as recommended by the Calicut University, during the academic year 2013-14. The Management has executed an agreement with Government which is read as 2nd paper above.

In this circumstances Government are pleased to issue NOC for starting the new self-financing/unaided college by the name "Sahya Arts & Science College", Kalikavu road, Wandoor, Malappuram, under the Sahya Tourism & Pravasi Co-operative Society Limited, Wandoor, Malappuram with the new unaided courses of B.Com Finance(30 seats), BA Travel & Toursim(30 seats), BBA(30 seats), B.Sc.IT(24 seats), and BA.English(24 seats) , as recommended by the Calicut University, during the academic year 2013-14, subject to the following conditions.

1. The Educational Agency shall submit the documents to prove that the College has adequate infrastructure, human and physical to conduct the course as required by the Government.
2. The Educational Agency shall abide by the procedure of admission in the college as decided by the Government from time to time.
3. The Educational Agency shall set apart 50% of the seats of the course for being filled up by the Government or such authority determined by Government on the basis of merit and reservation principles followed by the Government and the remaining 50% filled by the Educational Agency on the basis of merit.
4. The Educational Agency shall collect only such fees as determined by the Government from time to time from the students admitted to the college for the course.
5. The Educational Agency shall institute adequate number of scholarships on merit cum means basis as determined by the Government from time to time to the students admitted to the course.
6. The Educational Agency shall appoint and fix the service conditions of the teachers and non teaching staff in the college for conducting the course as followed by Government in conducting similar courses.
7. The Educational Agency shall institute an appropriate governance structure that

would ensure transparency, efficiency and social accountability in the Educational agency as determined by the Government from time to time.

8. The Educational Agency shall publish the details regarding the establishment and governance of Educational agency, admission, fees, courses, results, teaching and other staff, and any further information as required by the Government on the website of the Educational agency.
9. The Educational Agency shall run only courses approved by the Government and the concerned University.
10. The Educational Agency shall enable the Government and its representatives to check, verify and monitor the compliance of the conditions mentioned above at any time the Government so decides.
11. The Educational Agency shall enter into an agreement with the affiliating University on the terms determined by the affiliating University in respect of all or any of the matters contained in this agreement.
12. In the event of breach of any of the conditions mentioned above by the educational agency, the Government is authorized to adjudicate the quantum of compensation which the Educational agency is liable to pay to the Government, if any, and upon such adjudication, the Educational Agency shall pay to Government the amount so fixed, failing which the amount of compensation adjudicated should be recoverable under the provision of Kerala Revenue Recovery Act, 1968, as if they were public revenue due on land.
13. The No Objection Certificate granted shall be valid up to the end of the Academic year 2013-14, and renewable on the request of the Educational Agency and subject to the satisfactory compliance of the conditions specified herein.
14. In the event of the breach of any of the conditions mentioned above by the educational agency, the Government shall also be entitled to withdraw the sanction without formal notice to the Educational Agency.



**ORDER**

The President, Sahya Tourism & Pravasi Co-operative (STPC) Society Ltd, Wandoor PO, Malappuram 679 328 had applied for starting a new Arts and Science college at Wandoor for the academic year 2013-2014 and 2014-2015 as per the reference read as 1<sup>st</sup>.

As per the reference read as 2<sup>nd</sup>, it was recommended with BCom. (Finance), BA Travel and Tourism, BBA, BSc IT and BA English degree programmes with an intake of 30,30,30,24 and 24 students respectively for the consideration and the concurrence of the Govt. of Kerala, in the wake of the provisions stipulated in the UGC (Affiliation of Colleges by Universities) (1st Amendments) Regulations, 2012, pertaining to the requirement of land for starting new colleges.

The Govt. of Kerala have accorded Administrative Sanction and issued No Objection Certificate for starting a new Self-Financing/Unaided college by the name, Sahya Arts and Science College (unaided), Kalikavu Road, Wandoor, Malappuram, under the Sahya Tourism & Pravasi Co-operative Society Limited, Wandoor, Malappuram with the new unaided courses of BCom with Finance (30 seats) BA Travel and Tourism (30 seats), BBA (30 seats), BSc IT (24 seats) and BA English (24 seats) degree programmes for the academic year 2013-2014 as per the reference read as 3<sup>rd</sup> and 4<sup>th</sup>.

The Principal and the Manager, Sahya Arts and Science College (unaided) Kalikavu Road, Wandoor, Malappuram have submitted an undertaking to the effect that the college shall carry out faithfully the provisions of the University Act, Statutes, Ordinances and Regulations and directions issued by the University from time to time and admit only such students who are eligible as per the regulations of the University. They have also agreed that the University can proceed with strict actions including withdrawal of affiliation of the college, if anything is done by them, against the interest of the University or the student community.

An amount of Rs 75,000/- has been remitted towards the administration/affiliation fee as per the Chalan No. nil dated 05.07.2013 at SBT Calicut University.

Considering the above, as per the minutes read fifth above, Syndicate has approved granting provisional affiliation for starting a new self financing Arts and Science College in the name, Sahya Arts and Science College (unaided) Kalikavu Road, Wandoor, Malappuram under the management of Sahya Tourism & Pravasi Co-operative (STPC) Society Ltd, Wandoor PO, Malappuram for the academic year 2013-2014, with the unaided courses mentioned above.

Syndicate, vide item No. \*2013.360 dt. 16.05.2013 and 2013.\*360 (emended vide item No. 2013.429 dated 27.05.2013), resolved that the final verification of land documents can be done while issuing affiliation order. D.L.C, Malappuram has reported that they have verified the land documents of the educational agency for starting the new college and found that the Trust possess sufficient land without any encumbrances, required for starting the proposed college, as per the new guidelines.

Sanction is therefore accorded for granting provisional affiliation for starting the new Self-Financing/Unaided Arts and Science College in the name, Sahya Arts and Science College (unaided) Kalikavu Road, Wandoor, Malappuram under the management of

Sahya Tourism & Pravasi Co-operative (STPC) Society Ltd, Wandoor PO, Malappuram 679 328 for the academic year 2013-2014, with the courses as detailed below.

Selection and admission shall be made only on the basis of the Rules and Regulations of the University/Government and on the basis of the directions of the issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled.

In the light of the direction of the Supreme Court of India in W P © 656/1998, the institution shall take appropriate measures for prevention ragging in any form. In case of failure to prevent such instances appropriate action including withdrawal of affiliation of the college will be initiated.

Affiliation granted is strictly provisional and only for the academic year 2013-2014. The College has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University.

Admission to the next academic year shall be made, only after obtaining prior permission from the University.

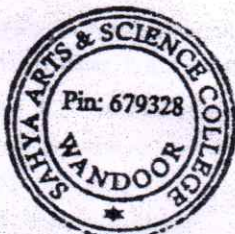

As per the application read as 3<sup>rd</sup> paper above, management of the Educational Institution has requested Government to renew the NOC for the academic year 2023-24. The management has completed the formalities for renewal of the NOC in the revised pattern.

2. In the circumstances, Government are pleased to renew the NOC for conducting the following self-financing / un-aided courses in Sahya Arts & Science College, Palamadam, Wandoor, Malappuram for the academic year 2023-24:-

1. BA English Language and Literature (36 seats)
2. BA Economics (60 Seats)
3. B.Sc Chemistry (24 Seats)
4. B.Sc Psychology (36 seats)
5. B.Sc Geology (24 Seats)
6. B.Com Finance (45 Seats)

7. B.Com Co-Operation (60 Seats)
8. B.Com computer Application (45 seats)
9. Bachelor of Business Administration (BBA) 45 seats
10. M.Com Finance (20 Seats)
11. M.Sc Psychology (10 Seats)

3. The renewal sanction of NOC is subject to the following conditions:

1. The Educational Agency shall give an Undertaking to the University about the presence of adequate infrastructure for conducting the course and the presence of adequate NET qualified faculty.
2. The Educational Agency shall abide by the procedure of admission as decided by Government and set apart 50% of the seats of the course for being filled up by Government or such authority determined by Government on the basis of merit and reservation principles followed by Government and the remaining 50% to be filled up by the Educational Agency on the basis of merit.
3. The Educational Agency shall collect only such fees as determined by Government from time to time from the students admitted to the college for the courses.
4. The Educational Agency shall institute adequate number of scholarships on merit-cum-means basis as determined by Government from time to time to the students admitted to the courses.
5. The Educational Agency shall maintain a website and publish the details regarding the establishment and governance of the Educational Agency, admission, fees, courses, results, teaching and non-teaching staff, grievance redressal mechanism for students and any other information as required by Government.
6. The Educational Agency shall run only courses approved by Government and the University concerned.
7. The Educational Agency shall enable Government and its representatives to check, verify and monitor the compliance of the conditions mentioned above at any time Government so decides.



8. The No Objection Certificate / sanction granted shall be valid up to the end of the academic year 2023-24 and renewable on the request of the Educational Agency and subject to the satisfactory compliance of the conditions specified herein.

9. The service of the teaching and non-teaching staff of the aided stream shall not be utilized for the proposed unaided courses.

10. The College shall seek NAAC accreditation by the year 2024.

11. There shall be no financial commitment to Government for the proposed unaided course.

12. In the event of breach of any of the conditions mentioned above by the Educational Agency, Government is authorised to withdraw the sanction without notice to the educational agency, or adjudicate the quantum of compensation which the Educational Agency is liable to pay to Government, if any, and upon such adjudication, the Educational Agency should pay to Government the amount so fixed, failing which the amount of compensation adjudicated should be recoverable under the provision of Kerala Revenue Recovery Act, 1968, as if they were public revenue due on land.

13. The educational agency shall produce necessary documents for the continued affiliation from the University for the year 2023-24 before 31.08.2023 failing which the sanction issued will be treated as cancelled w.e.f. 01.09.2023 and Government will not be responsible for any loss incurred by the institution and the institution shall be solely responsible for the losses thereof.

14. The college shall apply for renewal of NOC by March every year.

**ORDER**

1. In accordance with Notifications read as 1<sup>st</sup> and 3<sup>rd</sup>, applications were received from various colleges affiliated to the University of Calicut for permanent increase of seats in existing programmes for the academic years 2019-20 and 2020-21.
2. A Commission was constituted vide U.O. cited 2<sup>nd</sup> for conducting inspection in connection with sanctioning of new colleges, new programmes and permanent increase of seats for the academic year 2019-20. Since it was not feasible to conduct inspection in all the applicant colleges by the said Inspection Commission, District Level Inspection Commissions were entrusted for verifying the facilities available in the colleges applied for permanent increase of seats for the academic years 2019-20 and 2020-21 vide U.O. read as 4<sup>th</sup>. But permanent increase of seats was not granted during the academic years 2019-20 and 2020-21 due to outbreak of Covid - 19 pandemic.
3. A meeting of Conveners of District Level Inspection Commissions was held on 27/09/2022 for disposal of applications received in the University in prescribed format and remitting required fee for granting permanent increase of seats of existing programmes in affiliated colleges for the academic years 2019-20 and 2020-21, which recommended to grant permanent increase of seats upto 50% of the sanctioned strength in existing programmes in tune with applications received for permanent increase of seats for the academic years 2019-20 and 2020-21, subject to following conditions.
  - i. Sanctioning of permanent increase of seats shall be subject to the maximum intake prescribed by Calicut University First Statutes, 1977.
  - ii. Increase of seats demanded in the applications, 50% of existing sanctioned strength,

Statutory limit, whichever is less will be granted as permanent enhancement.

iii. Permanent enhancement will come into existence w.e.f. the academic year 2023-24.

iv. Approval from the regulatory body is mandatory for granting permanent increase of seats to programmes concerned.

4. Meeting of the Syndicate held on 11/10/2022, vide paper read as 6<sup>th</sup>, has considered the aforementioned recommendations of meeting of the Conveners of District Level Inspection Commissions held on 27/09/2022 and resolved to approve the same.

5. After considering the matters in detail, sanction has been accorded by the Vice Chancellor to implement the resolution of Syndicate vide item no. 2022.1141\* dated 11/10/2022.

6. Orders are, therefore, issued granting permanent increase of seats for the existing UG and PG programmes in colleges affiliated to University of Calicut with effect from the academic year 2023-24, as per the list appended, subject to conditions specified in Para (3).

7. Principals of colleges concerned shall produce renewal NOC from Govt. of Kerala for the programmes with permanently enhanced intake while applying for Continuation of Provisional Affiliation.

8. Permanent increase of intake sanctioned is subject to the condition that it should not involve any additional staff and financial commitments either to the Government or to the University. Admission to the permanently increased seats should be made strictly as per rules issued by the University/Government.
